(1) It is hereby declared that the Founders do hereby settle on the Trustees hereinafter mentioned the same sum of Rs.4,020/- (Rupees Four Thousand and Twenty Only).

(2) It is hereby declared further that the Trustee hereinafter mentioned shall stand possessed of the said amount and shall utilise the said amount and the income there from as well as all receipts, accumulations and accretions there to by way of contributions, donations, subscription, or otherwise forming the Trust Fund for the objects, intents and purpose hereinafter mentioned.

(3) The name of the trust shall be **SRI KARUPPA GOUNDER CHARITABLE TRUST** and the Principal place of the trust shall be at 1/25-B, Reddipatti -Post, Namakkal Taluk & District.

(4) The object of the trust shall be :-

(a) To build,construct, establish, take-over, run,maintain, manage and/or render financial help to any education and/or Scientific institutions for imparting education in Arts, Grafts, Science, Medical, Engineering, Vocational and Technical subjects, or for research in any or all of the above.

(b) To construct, establish, run, maintain, manage and/or render financial help to Matriculation Schools, one or more polytechnic Institutions or other Centres for the training of young men and women in technical, mechanical, scientific, and similar pursuits.

(b) The number of Trustees shall not be less than 3 and not more than 10. The existing or continuing Trustees shall have the power of appointing further or additional Trustees within the numbers prescribed hereinabove either in the place of those retiring or becoming disqualified to hold office or as new trustees.

(c) In the case of any vacancy in the Trust Board arising by death of resignation or otherwise, the remaining trustees will have full powers to represent the Trust Board. The Trustees shall have, in such an event, power to co-opt a Trustee to fill up the vacancy.


(7) Any trustee shall be at liberty at all times to retire from the Trust and shall also be entitled to be disqualified to hold office if he becomes or is declared to be an insolvent or to be of unsound mind whether or not found by inquisition or shall otherwise become unfit or incapable to act or resign from the trusteeship.

(8) The Trustees will be entitled and be at liberty to accept gifts or voluntary contributions from any persons install charity boxes and/or otherwise collect subscriptions or donations to augment the Trust Fund and use such monies for the objects of the Trust. It shall always open to the Trustees in their absolute discretion to accept or refuse any such donations, gifts and/or contributions.

(9) The Trustees shall be at liberty to merge or amalgamate the Trust Funds with the Funds, properties and assets of any other trust or trusts having objects similar to those of those present.

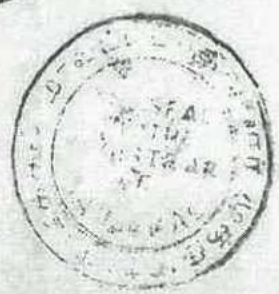

(11) Once in five years, a new board of trustees shall be elected from the general body of trustees, as at that time and a retiring member of the board of trustee shall be eligible for re-election.

(12) The Trust shall be managed by the Board of Trustees through Chairman and the Chairman shall have the powers of day-to-day management and administration of the Trust. He shall have power of day-to-day administration of the Educational Institutions as Correspondent.

(13) The bank accounts shall be operated jointly by the Chairman and Treasurer.



(14) Without prejudice to the generality of their powers, the Trustees shall have powers, atleast by way of option of the majority of the Trustees.

(iii) To Purchase or to acquire or hire any immovable or movable property of the Trust on such terms and/or such value or consideration and/or for such period as the trustees may think fit.

(iv) To let any portion or any immovable property forming part of the Trust on such terms and/or at such value or consideration and/or for such period, as the trustees may think fit.

(v) To let any portion or any immovable property forming part of the Trust Fund at such rent and for such period and on such terms and conditions as the Trustees think fit.)

(vi) To borrow or raise money with or without security or pledge or mortgage or otherwise charge any of the properties belonging to the Trust for carrying on the objects and purposes of the Trust.

(vii) To open and maintain banking accounts in the name of the Trust or in the name of the School as the Trustees may decide and to make the said banking account(s) operable by two or more of them as they may decide from time to time.

(viii) To appoint proxy or proxies for voting at any meeting.

(ix) To delegate all or any of these powers to one or more of their body.

(x) To delegate any power as they can lawfully delegate to any person and to execute such power of attorney as they may think fit for the purpose.

(17) The Trustees shall have the power to sell, convert or otherwise release any of the trust properties, invest the funds of the Trust in any form of investment or change/alter the form of investment where they are satisfied that such investment will yield a reasonable income or where it is deemed expenditure necessary for carrying out the objects of the Trust, provided that such investments shall be in accordance with the investment pattern provided for in the income-tax, Act, 1961 from time to time.



a) The income and funds of the Trust will be solely utilized towards the objects of the Trust and no portion of it will be utilized for payment to trustees by way of Profit, interest, dividends etc and the benefits of the Trust will be open to all irrespective of caste, religion, sex etc.

b) The Trust will not carry on any activity with the intention of earning profit and no activities of the Trust will be carried out outside India.

c) All the aforesaid First Board of Trustees shall hold office as such for the duration of their respective lives or until they resign and each of them shall have the right to nominate their successors by will or otherwise.

d) The Managing committee shall be responsible for maintenance of Accounts of the Trust, and the accounts shall be closed on the 31st day of March every year and Income & Expenditure account and Balance sheet as on that date be prepared and shall be submitted for audit by a Chartered Accountant duly appointed by the Board every year.
